Women's entrepreneurship development centers operate in 17 regions.

From 2023, they will operate in all regions of Kazakhstan.

The Women's Entrepreneurship Development Center provides 7 types of services based on women needs and requests.

- Rendered 8 705 services;
- > Trained 4 656 women;
- Successfully performed business assessment for 170 companies;
- > Provided mentor service for **201** women.





«Women in Business» is an annual women's forum, that has attracted about **2000 women entrepreneurs** for all the time of its organization.

This Forum is a dialogue platform for discussing topical issues of women's entrepreneurship and networking development. It offers master classes on sales and financial literacy.
